The diploma will enable the trainees to acquire knowledge, skills and competencies in interpreting Indian Sign Language into other spoken languages and vice versa.

Diploma in Indian Sign Language Interpretation (DISLI) is a course recognized by the Rehabilitation Council of India (RCI) and its main aim is to prepare skilled and efficient manpower to work effectively in the field of deaf education and rehabilitation.

The graduates of DISLI course may work as interpreters in schools, colleges, institutes where the deaf population study and work and other places where interpreting services are required. This course will also help teachers of the deaf to effectively communicative with their students.

ELIGIBILITY FOR ADMISSION:

A Candidate should have:

- Functional hands
- Fluency in at least one language
- Hearing in the normal range

COURSE FEES:

- 1. Semester Fee Rs. 10,000/- per semester (Rs. 8,000/- Training + Rs. 2,000/- Library Fee)
- 2. Caution Money Rs. 5,000/- (It will be refunded to the student after completion of the course).

Note:

- a) PwD candidates having UDID card with benchmark disability (40%) are exempted from course fees
- b) The candidates offered admission would have to deposit caution money as stated earlier. The caution money is refundable after recovering the losses/damages in Institute, if any, on the successful completion of the course.
- c) However, if a student discontinues on his/her own reason before completion of the course, the entire caution money will be refunded after recovering the losses/damages in Institute and after completion of the course duration only.
- d) In the event of the candidate withdrawing from the course, the entire fee and deposits paid at the time of admission stand forfeited and in addition, any sums expended by the Institute in training the candidate may have to be refunded by the candidate as per the terms and conditions of the Institute concerned.

GENERAL RULES

- a) The candidates must follow all guidelines laid down by **Rehabilitation Council of India** (available at **www.rehabcouncil.nic.in**).
- b) The candidates once selected in the course will have to deposit the course fee and caution money as per Institute norms. In the event of the candidate withdrawing from the course, the entire fee and deposits paid at the time of admission stand forfeited and in addition, any sums expended by the Institute in training the candidate may have to be refunded by the candidate as per the terms and conditions of the Institute concerned. However, only caution money shall be refunded.
- c) The Institute reserves the right to reject incomplete application form.
- d) The candidates should bring their original certificates at the time of Document verification.
- e) The candidates should scrupulously follow the rules of discipline and code of conduct as framed by the Institutes from time to time.
- f) Any legal matter related to DISLI course will be dealt under jurisdiction of Hon'ble High Court of Tripura.

GENERAL INSTRUCTIONS FOR FILLING UP OF APPLICATION FORM: -

- 1. The candidates should provide all the authentic details while filling up the form.
- 2. Candidate must attach self-attested photocopy of all the relevant certificates/ documents during filling up the form:
 - a. Recent passport size Photograph,
 - b. Signature,
 - c. Caste Certificate (For Candidates seeking Category Reservation)
 - d. PWD Certificate (For Candidates seeking Reservation under PWD Category, Submit UDID card if candidate is a UDID card holder).
 - e. Madhyamik (10th) and Higher Secondary (10+2) Marksheets.
- 3. Application form must be complete in all respect.
- 4. Claim for admission will be rejected if the candidate cannot submit the original certificates, mark sheets, other necessary documents at the time of document verification.
- 5. Admission will be cancelled at any time, if certificates/ mark sheets/ other documents are found to be forged or manipulated. A candidate will not be considered for admission if he/she fails to substantiate the claim with respect to reservation, category, date of birth, qualification etc.
- 6. If any information furnished by the candidate found false later on, his/her admission will be forfeited without notice and legal action deemed fit will be initiated against the student.
- 7. Documents/certificates will be verified at CRC SRE Tripura, Narsingarh, Agartala, West Tripura and the same will be sent to Rehabilitation Council of India for final admission.
